

Attached is the application you need to complete to join the Sun Valley Figure Skating Club (hereafter, "SVFSC" or "Club"). Club memberships run from **July 1st to June 30<sup>th</sup>**, following the skating year defined by U.S. Figure Skating.

A membership in the SVFSC gives you membership in our non-profit club as well as a U.S. Figure Skating membership. As a non-profit club, we are governed by bylaws and a volunteer Board of Directors that set goals and budgets for our club. All full members of the Club, aged 18 and over, have a vote in our club governance. If you are an adult applying for a child under 18, you must join as a second family member if you wish to have a vote. Please be sure to complete all pages of the application. We cannot process your membership until all forms are completed and returned with your fees.

The SVFSC offers the following types of Memberships:

### **Full Adult Membership**

For adults 18 or older, the Full Adult Membership entitles the member to the right to vote, hold office, and enjoy all the privileges of the Club and US Figure Skating.

*Dues \$90.00/year first member \$60.00per additional family members.*

### **Full Junior Membership**

For skaters under 18, the Full Junior Membership entitles the skater to skate in all the club's activities and enjoy all the privileges of US Figure Skating. The Full Junior Membership provides all of the benefits you need for U.S. Figure Skating testing and competition. Benefits of this membership include:

- U.S. Figure Skating membership, which includes a subscription to Skating Magazine
- Club certification (signatures for entry) for all U.S. Figure Skating competitions
- Eligibility for U.S. Figure Skating testing in freestyle, moves in the field, pairs and dance
- First priority for space on SVFSC testing, exhibitions, club parties, shows and recitals.

*Dues: \$90/year for first family member, \$60/year for each additional family member.*

### **Collegiate Membership**

The Collegiate Membership is a four-year full membership at a reduced rate for college students who are former Junior SVFSC members, who have residential ties to the Community or as approved by the SVFSC Board of Directors. The Collegiate Membership entitles the skater to the same privileges as the Full Junior Membership for four consecutive years. Eligible skaters may apply for the Collegiate Membership only once. They may apply any time they are enrolled in college, not just in their freshman year.

*Dues: \$70.00 for a four year membership.*

### **Professional Membership**

For professionals (ineligible) in figure skating, the Professional Membership entitles members to the right to vote and to enjoy all the privileges of the Club and of US Figure Skating, except that Professional Members may not hold office in SVFSC. Please note: To be eligible for a Professional Membership, coaches must have completed the U.S. Figure Skating coach registration process and appear on the approved US Figure Skating list. They must also be CER compliant for the current year as per the PSA. *Dues: \$90/year*

**Associate Membership:** Members of another US Figure Skating club or friendly foreign federation may join SVFSC as Associate Members. They shall have all privileges except that of voting and holding office. They will not represent the SVFSC in competitions or other US Figure Skating activities. Associate Members will need permission from their home club to participate in SVFSC shows and test sessions, and shall need permission from their home club and primary coach to be included in SVFSC press releases. *Dues: \$60/year*

## **Membership Agreement**

### **Agreement to Follow SVFSC and USFS Rules**

### **Press Policy**

I understand that all press submissions concerning figure skating must be made through SVFSC. I understand that direct press submissions, or submissions solicited from others on my behalf, constitute a SVFSC rule violation.

### **Volunteer Requirements**

I understand that the SVFSC relies heavily upon the volunteer support of all its members. Minimum volunteer requirements for each skater 10 years and older is 4 hours of service to the club during any of its annual competitions or fundraisers. Minimum volunteer requirements for each parent of a SVFSC Jr. Member are 10 hours of service to the club during any of its annual events. SVFSC requests all adult members, junior skaters age 10 and older, and at least one parent for each junior skater to volunteer in some capacity at the Sun Valley Summer Championships either during the event or beforehand. All adult members and skater families are requested to contribute a dish of food to the officials' meals at this event.

### **Residency**

The SVFSC requires that competitive members of the SVFSC must be full time residents of Blaine County and/or be enrolled in a Blaine County School, or as approved by the SVFSC Board of Directors.

### **Club Jacket Requirement**

All junior competitive members representing the SVFSC at competitions and test sessions must wear SVFSC jackets.

### **Acceptance of Terms**

### Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement (“Agreement”)

In consideration of participating in Sun Valley Figure Skating Club (hereafter “Sun Valley FSC,” “SVFSC,” or “Club”) activities, I represent that I understand the nature of figure skating activities (“activity”) and that I am qualified, in good health and in proper physical condition to participate in such “activity”. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the “activity”.

I fully understand that this “activity” involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the “activity”, the conditions in which the “activity” takes place, or the negligence of the “releasees” named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the “activity”.

I hereby release, discharge, and covenant not to sue the Sun Valley FSC , United States Figure Skating, it’s directors, officers, administrators, sponsors, volunteers, agents, employees, staff, instructors, trainers, other participants and if applicable, owners and lessors of premises on which the “activity” takes place (each considered one of the “Releasees” herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the “releasees” or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk, I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the releasees from any loss, liability, damage, or cost which any may incur as the result of such claim.

The Sun Valley FSC has the right, but not the obligation, to provide rules, regulations and/or ice monitors for Club Ice. We hereby acknowledge that the Sun Valley FSC shall not be responsible for the supervision of the members at any time, including, but not limited to Club Ice.
